

# **CSF Community Competition – Terms and Conditions**

#### 1. Promoter

This competition is organised and promoted by **Central Security & Fire** ("the Promoter"), a company based in South Wales.

# 2. Eligibility

- 2.1. Entry is open exclusively to registered charities, social enterprises, and community enterprises operating within the United Kingdom.
- 2.2. Registered charities must hold a valid charity registration number issued by the Charity Commission for England and Wales, consisting of nine digits.
- 2.3. To qualify, the organisation's main premises or operational address must be within a ten (10) mile radius of postcode NP23 4YF.
- 2.4. Entries submitted by individuals, for-profit businesses, or unregistered community groups will not be accepted.
- 2.5. The Promoter reserves the right to request documentation verifying eligibility before awarding any prize.

### 3. The Prize

- 3.1. The prize consists of a voucher redeemable with CSF Security & Fire for products and/or services up to a total stated value (as advertised).
- 3.2. The voucher must be redeemed in full within six (6) months of the date the winner is notified.
- 3.3. Any associated installation, supply, or service work must be completed no later than 31 December 2025.
- 3.4. Any unredeemed balance after the expiry date will be forfeited. The prize has no cash value and cannot be exchanged, transferred, or refunded.

#### 4. Winner Selection and Notification

- 4.1. Winners will be selected according to the method outlined in the competition announcement (e.g. random draw or judging panel).
- 4.2. Winners will be contacted via the details provided at the time of entry.
- 4.3. If a winner cannot be contacted within 14 days, or fails to provide proof of eligibility, the Promoter reserves the right to withdraw the prize and select an alternative winner.

## 5. Publicity and Data Protection



- 5.1. By entering, participants consent to the Promoter using their organisation's name, logo, and brief description for publicity, promotional, and marketing purposes in connection with the competition.
- 5.2. Any personal or organisational data provided will be processed in accordance with the UK General Data Protection Regulation (GDPR) and the Data Protection Act 2018.
- 5.3. Data will be used solely for the administration of this competition and will not be shared with third parties except as required by law or for competition fulfilment.
- 5.4. Participants may withdraw consent or request data deletion by contacting hello@c-s-f.co.uk.
